## Message from our Board Chair

### Remember "It Takes A Village?"

No one needs to be reminded that tasks are easier to accomplish if everyone works together — from clearing the table after a big meal to.... getting cats healthy and happy again. Alley Cat Advocate volunteers experienced this in a BIG way after our March BIG FIX.

Although relatively uncommon, several of the cats who came to be spayed or neutered that warm weekend in March had severe medical issues beyond needing to be just spayed or neutered. One young, playful boy had a bite wound directly over his front elbow, one big, beautiful orange boy had had a broken leg for a couple of years(!) and dragging it around kept him with an open wound where he pulled it on the ground, and another big fluffy boy clearly had had a puncture wound to his eye that had resulted in a very bad infection. In each case, neutering the guys was easy and straightforward. But what about the other issues?

Fortunately, we had a little money in the Billie Emergency Fund. (See page 3 for a description of beautiful Billie and her fund.) But even more helpful were the volunteers, in particular the veterinarians this time around, who really made the difference for these cats.

The young, playful boy needed wound treatment, a skin graft, and cage rest for several weeks. One generous vet took this case on, for a very discounted rate, and got this little man up and playing again, fully healed.

The beautiful orange boy had two vets help him out. While one vet amputated his damaged leg at no charge, another provided cage rest prior to his amputation and her staff provided lots of physical therapy (and love!) afterward. What a lucky boy to have so many watching after him.

And our big fluffy boy had yet another vet remove his badly infected eye at a discounted rate while his caretaker kept him comfortable and quiet for several weeks while he healed.

It isn't often (thank goodness!) that we have this many special challenges with the cats we spay and neuter but it sure is great to know that when we do, we know we can get the cats all the help they need. A special thanks this month to those vets who actively support the work we do (see page 2 for a list) and step in to give that extra help when needed. It is one thing to know that "it takes a village." It is another to see the difference it makes for the cats!

## Billie's Happy Story

And what a happy story it is to share! Well, it starts out sad but then it gets happy! In the summer of 2001, several of our volunteers were busy trapping, altering, and returning cats in a block where a momma cat lived. A neighbor watched this momma cat carefully moving her kittens over a wood privacy fence. Under the weight of one of her kittens, however, she fell and caught her leg between two wooden slats. It was severely broken. The nice man watching her came to her rescue or so he hoped. The momma, in pain and scared for herself and her kittens, fought the man, bit him, and scampered away with her very painful leg. After many long hours and much neighborhood reconnaissance work over the next three weeks, an Alley Cat Advocates volunteer finally trapped the momma cat. By then, it was clear that the momma would die unless the leg was amputated.

At that time, thanks to many generous donations,

Alley Cat Advocates had the funds available for the procedure. As a result, today, Billie, as she is now known, is a feisty three-legged girl with no more wood privacy fences in her way — just sunshine and kitty friends fill her day.

We were glad that we didn't have to make the decision to euthanize Billie due to lack of funds to pay for her amputation. But we recognized that this situation would probably arise again. And we didn't want to find ourselves without funds as we might have to make a different decision. To help prevent such an outcome, we established a special fund in Billie's honor to cover the cost of just such life saving procedures for the cats we've trapped to spay and neuter. 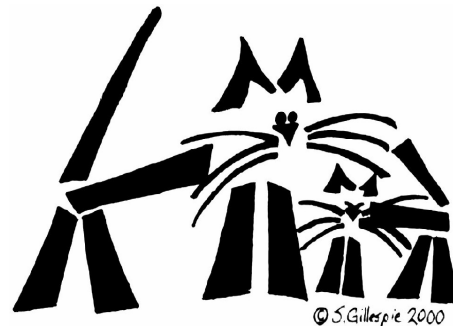

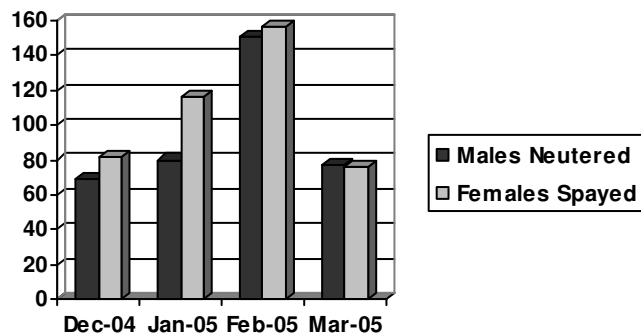
